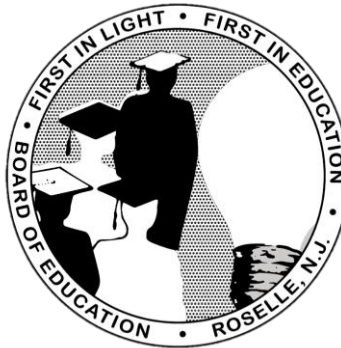

Half-Day Schedule

A half-day schedule will be followed for Parent-Teacher Conference dates, some Staff In-Service days, as well as the day preceding the Thanksgiving Holiday, Memorial Day Holiday, Spring and Winter breaks, and the last day of classes for students. The Half-Day dismissal time for Pre-K is 11:20 a.m., Grades K-8 is 12:45 p.m., and Grades 9-12 is 12:30 p.m.

Delayed Opening Schedule

In case of inclement weather, the Superintendent will make the announcement of delayed opening by 5:30 a.m. through the School Messenger System. Delayed school opening will also be posted on the district website.

Before School Programs will be suspended on delayed opening days. Classes will begin at 10:00 a.m. and end at the regularly scheduled times. Students should **not** report to school before 10 a.m. on delayed opening days.

Expectations

The following expectations serve as a guide for students, parents, teachers and administrators. We work together as a community to promote the growth of our students as a whole person, and help them succeed academically, socially and emotionally.

Students are expected to:

- Attend school regularly and punctually
- Come prepared for classes, complete all classwork, submit homework in a timely manner
- Participate in classroom work and discussions
- Be accountable for their actions
- Act responsibly with consideration for others
- Appreciate and respect one another's differences
- Resolve differences using discussion and assistance from school personnel
- Follow school rules and regulations
- Dress appropriately in school uniform
- Be substance and drug free

Parents are expected to:

- Support the school's goals and standards of discipline set for the students
- Ensure that their child attends school regularly and punctually
- Make sure their child comes to school well prepared for class
- Train their children to take responsibility for their own actions
- Instill in their children a healthy respect for authority
- Communicate with staff members, in a timely manner, regarding their child's progress
- Encourage discipline and good behavior at home and in school
- Maintain open lines of communication, update contact information as needed, attend school meetings and conferences
- Cooperate with the school for the benefit of the child

Faculty and Staff will:

- Create and maintain a safe, productive learning environment
- Adhere to District/School rules
- Communicate with parents in a timely, consistent, and effective manner
- Keep parents informed of the student's progress and other concerns
- Serve as role models for the students
- Develop classroom / time management strategies for optimal student learning
- Support and promote positive classroom interactions
- Encourage students to strive for excellence and develop their individual abilities
- Create lesson plans that are engaging, challenging, and stimulating for all students
- Provide education that supports students' development into productive citizens

Student Code of Conduct

The Student Code of Conduct serves to support a positive learning environment and for the efficient operation of the Roselle Public Schools. The rules have been compiled in a manner that allow students to understand the consequences for their actions. Failure to live up to school’s rules and regulations entails disciplinary consequences.

This document is not meant to be inclusive of all infractions that may occur in the school. Consequences to conduct violations will be imposed on a case by case basis at the discretion of the building Principal or Administration. In some cases, a consequence other than that listed here may be imposed. The severity of the offense, the developmental age of the student, and the student’s history of inappropriate behaviors will all be considered when imposing discipline for conduct violations. The Superintendent has the flexibility to make exceptions or to take actions other than those specified.

Possession / Distribution of a Substance - "Substance" means alcoholic beverages, controlled dangerous substances, i.e. anabolic steroids as defined at N.J.S.A. 24:21-2 and N.J.S.A. 2C:35-2, any chemical, chemical compound, which releases vapors or fumes causing a condition of intoxication, inebriation, excitement, stupefaction, or dulling of the brain or nervous system, including, but not limited to, glue containing a solvent having the property of releasing toxic vapors or fumes as defined at N.J.S.A. 2C:35-10.4 and over-the-counter and prescription medications which are improperly used to cause intoxication, inebriation, excitement, stupefaction, or dulling of the brain or nervous system.</p>			

The authority of any administrator, teacher or other Board of Education employee shall extend over every student whether or not he/she has direct responsibility for the student(s) in every area of school property, on school vehicles, at any time, and at all school functions, regardless of location, whether or not school is in session.

Students in Special Education Programs

The Roselle Public Schools offer the full continuum of placements to meet the needs of students with disabilities ages three through twenty-one for special education and related services.

For students with disabilities, subject to Individualized Education Programs, the Code of Student Conduct shall be implemented in accordance with the components of the applicable plans.

The district assures that physical restraint and seclusion techniques on students with disabilities are only used in an emergency in which the student is exhibiting behavior that places the student or others in immediate physical danger in accordance with the provisions at *N.J.S.A. 18A:46-13.4 et seq.*

Dress Code

Students are required to come to school wearing the prescribed school uniform. Exceptions to this rule are for school sponsored events such as Field Day and Dress Down Days. Parents are expected to ensure that their children report to school in clean school uniforms. Students have a responsibility to dress neatly and appropriately for school, and to be well groomed.

Parents will be asked to pick up their child from school, if the child comes to class in clothing other than the prescribed school uniform, or if their clothing is in violation of the overall dress code.

Absences

The Board of Education requires students enrolled in the school district to attend school regularly in accordance with the laws of the State. Students that are absent from school for any reason are responsible for the completion of assignments missed. Parents are expected to take the initiative in calling the school to ask for their child's homework.

It is the student's responsibility upon his/her return to school to meet with his/her teachers to arrange for make-up work. Absences for religious holidays or school sponsored events will not be counted in determining the total number of absences. See Policy 5200 for more detailed information.

Drug Free Zone

The Board of Education prohibits the unlawful manufacture, distribution, dispensing, possession or use of any controlled dangerous substance by any person in any school building, on school grounds, or during any activity or event sponsored by the Board.

Every employee and student of this district must agree to be bound by this policy. Anyone who violates this policy will be subject to discipline, which may include discipline or dismissal as appropriate.

Locker Searches

Policy 5770 authorizes the search of students' lockers or other storage facilities by the school Principal or other officials designated by the local Board of Education. The law provides that these inspections may take place as long as written notice is given to the students at the beginning of the school year. In compliance with this law, this is to notify our students that inspections of the aforementioned areas will be on-going during the entire school year.

Due Process

The Student Code of Conduct establishes essential regulations to maintain discipline in the operation of the schools, in order to effectively promote positive student development and academic success. The Student Code of Conduct clearly outlines the procedures followed to address misconduct, in order to ensure that disciplinary responses are appropriate to the misbehavior, distinguish between minor and serious offenses, as well as between single and multiple offenses, and are administered in a fair, consistent manner.

The Board of Education may deny participation in extra-curricular activities, school functions, sports, graduation exercises or other privileges as disciplinary sanctions when designed to maintain the order and integrity of the school environment, in accordance with N.J.A.C. 6A"16-7.1(d).

Any student to be disciplined shall be provided the due process procedures for students and their families as set forth in Policy and Regulation 5600 and N.J.A.C. 6A: 16-7.2 through 7.4.

Student Bill of Rights

- Right to an education that supports students' development into productive citizens
- Right to safe and secure school environments
- Right to attend school irrespective of marriage, pregnancy or parenthood
- Right to due process appeal procedures and policies
- Right to parent notification consistent with the policies and procedures established pursuant to N.J.A.C. 6A:16-6.2(b)3, this section and N.J.A.C. 6A:16-7.2 through 7.8
- Right to protection pursuant to federal and state laws and regulations
